- Members of the AAC met with Ms. Ashworth's Office on 22 March to discuss prosecution on animal cases. Ms. Ashworth said there are five (5) lawyers in her office that focus on cases. Ms. Ashworth recommended that the AAC work with the Police Dept to get more education on building case files. And Ms Ashworth recommended we look at how to educate the judges more on sentencing.

The Career and Technical Education (CTE) Support Team is researching/reviewing the program in its entirety; including job outlook (workforce development needs), requirements for: teacher credential/endorsement, classroom/lab space, and equipment; Work-Based Learning opportunities and partnership, and student certification opportunities and post-secondary education alignment.

Once the research/review is complete, the CTE Support Team will determine the next steps.

- Pitbull Subcommittee: Ms. Haufler provided an update on action points taken according to the priorities set for the pitbull subcommitte last Fall:
 - o No update this month
 - Spoke with 2 different galleries to create an art exhibition in late summer, with theme of pitbull awareness in order to fund a spay and neuter clinic for pitbull PWC residents.
 - Connected with Arts Council and met 2 artists that are willing to feature their art in the expo. As well as a school arts contact to bring students to participate.
 - Got information from tshirt fundraising company to help fundraising efforts for the initiative.

• The subcommittee is still investigating ways to route funding to an outside 501c3 to handle donations for the spay and neuter clinic initiative.
